Russ built a legacy based on integrity and hard work. He was committed to prudent financial management and was a valued business partner to the CEOs and management teams he worked with. His strong global business acumen, his commitment to open dialog and his honesty characterized all his actions

In addition to his professional accomplishments, Russ also earned a reputation for being a driven and dynamic person who remained positive even through hardship and always had a kind word for those around him. He was a mentor and a friend to many in the industry and will be sorely missed.

The company would like to express gratitude for Russ' contribution, as a colleague and a friend, and convey sincere condolences to Russ' family. A funeral Mass will be held in Wellesley, Massachusetts, on Tuesday, May 23, at 10:00 a.m. at St. John the Evangelist Church. A memorial service will be held in Austin at a later date.
